

SOCIAL MEDIA SWEEPSTAKES PROMOTION OFFICIAL RULES

NO PURCHASE NECESSARY. A purchase will not increase the chance of winning.

Eligibility. Social Media Sweepstakes Promotion (the “Sweepstakes”) is open only to legal residents of the state of Nevada who are at least 18 years of age at the time of entry (the “Entrant”). The Sweepstakes is void elsewhere and where prohibited by law.

Sponsor’s servers and clock shall serve as the official clock for the Sweepstakes and Entrants’ proof of submission does not constitute proof of receipt by Sponsor.

How to Enter. Prize Conditions.
